Members **AGREED** for Cllrs Revell, Reynolds, Barnes, and West to speak and vote on item 3.

**03     To consider and agree Councils response to North Norfolk District Council First Draft Local Plan (Part 1) in regards to Mundesley.**

The Chair informed members that the response needed to be one of factual based documentation and not an emotive exercise.
